

Bill Would Legalize Assisted Suicide in All Fifty States By Allowing "Suicide Tourism"

New Mexico House Bill 90 was introduced by Deborah Armstrong (Dem) to legalize assisted suicide. The bill is referred to as The Elizabeth Whitefield End of Life Options Act. On December 21 I published the article New Mexico Assisted Suicide Bill is the most dangerous bill ever (Link) where I explained how Bill HB 90 expands the scope of assisted suicide in the USA. The most concerning part of HB 90 does not have a residency requirement and it allows assisted suicide to be approved via tele-

medicine. Therefore, if legalized, Bill HB 90 will allow suicide tourism and legalize assisted suicide in all 50 US States. Assisted suicide is always dangerous and should never be legal because it enables one person to be involved with causing the death of another person with lethal drugs. Let's not be innocent, legalizing assisted suicide leads to the further degradation of people with disabilities and other people who are medically vulnerable while creating new paths for elder abuse and

the perfect legal defense for deaths not considered by the assisted suicide debate. There are many other concerns with Bill HB 90 such as the bill:
 • does not require the person to "self administer" thus it allows euthanasia (homicide),
 • allows nurses and physician assistants to participate in assisted suicide,
 • does not require a second assessor,
 • allows people with mental health disorders to die by assisted suicide, suicide,

requires health care providers to falsify the death certificate.
 • provides legal protection for anyone who participate in the act,
 • negates con science rights for health care providers by forcing them to refer for assisted suicide,
 • uses the undefined term "foreseeable future" for terminal illness,
 • while all of this is only held together by "good faith" compliance. HB 90 is so wide that you can drive a hearse through it. Michelle Lujan Grisham, the recently elected Democrat Governor of New Mexico stated during the election that she supports the legalization of assisted suicide. New Mexico has been debating assisted suicide for many years. During the previous legislative session the New Mexico Senate de-





BOISE, Idaho, Dec., 2018 /Christian Newswire/ -- Kara Cadwallader, vice president of medical affairs and senior medical director for Planned Parenthood of the Great Northwest and the Hawaiian Islands, said basic healthcare services would be discontinued because of the lack of patients asking for these services, reported Boise State Public Radio. Cadwallader said people had access to basic healthcare services elsewhere. Brandi Swindell is Founder and CEO of Stanton Healthcare which is a life-affirming women's health clinic located right next to the Boise Planned Parenthood clinic.

Ms. Swindell states; "By cutting primary health services but continuing to be an abortion vendor, Planned Parenthood has revealed what they truly are. That is, an abortion business which has become the largest abortion provider in the world." "Planned Parenthood likes to portray themselves as critical providers of women's healthcare across the nation yet federally qualified community health centers -- which do not provide abortions -- offer more comprehensive services than those offered by Planned Parenthood." These health centers out number Planned Parenthood clinics 20 to 1.

Planned Parenthood's own annual report shows most of its real healthcare services have been in decline over the past several years. Tragically during this time, their abortion business has increased. It is important to note, the services that Stanton provides to women in the Boise area have only increased during the same time period. "Planned Parenthood cutting health services in Boise only underscores the reality that they need to be defunded and the \$500,000,000 of public funds that they receive annually should be given to clinics that truly service and provide quality care to women." +++
